UNSAFE PRACTICES ASSOCIATED WITH THE TRAFFICKING OR TRANSPORT OF MIGRANTS BY SEA

First biannual report

- 1 The Maritime Safety Committee, at its seventieth session (7 to 11 December 1998), in approving MSC/Circ.896 on Interim measures for combating unsafe practices associated with the trafficking or transport of illegal migrants by sea, invited Member Governments to promptly convey to the Organization reports on relevant incidents and measures taken to enable the updating or revising of the circular.
- 2 The Committee, at its seventy-third session (27 November to 6 December 2000), agreed to establish a reporting procedure for dissemination by the Secretariat on a biannual basis and urged Governments and international organizations to promptly report all unsafe practices associated with the trafficking or transport of illegal migrants by sea they are aware of.
- 3 The Committee, at its seventy-fourth session (30 May to 8 June 2001), in the light of the reports recorded and proposals made by Governments, approved amendments to the annex to MSC/Circ.896. The report format appended to MSC/Circ.896/Rev.1 should be used for such reports.
- 4 Set out at annex 1 in the tabulated format agreed by the Committee is the summary of 139 reports on incidents, involving 8,050 migrants, received for the period from 1 August to 31 December 2005. Set out in annex 2 are the statistics for the calendar year 2005.
- 5 The total number of incidents related to unsafe practices associated with the trafficking or transport of migrants by sea so far reported to the Organization is 996, involving 46,839 migrants.

Attached is the statistical information on “Unsafe practices associated with the trafficking or transport of migrants by sea” prepared on the basis of 247 incidents reported to the Organization in the calendar year 2005 involving 17,513 migrants and 45 countries.

Contracting Governments are invited to provide to the Organization information on “Unsafe practices associated with the trafficking or transport of migrants by sea” in time. This circular compiles information submitted to the Organization during 2005, including some incidents occurred in 2004.

In preparing this document the Secretariat noted that the number of reporting States is very small. From 166 Member States only two have reported incidents to the Organization during the last six months. Italy has submitted 180 reports and Greece 67.

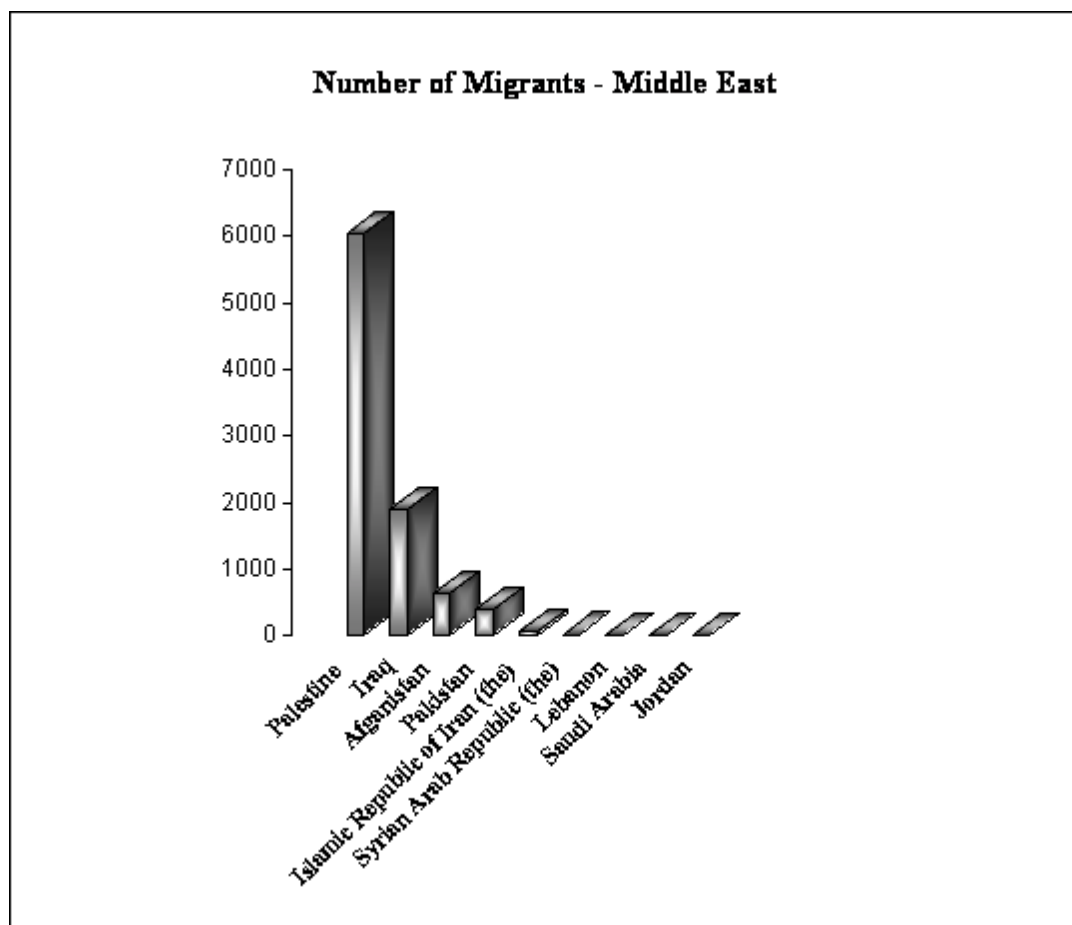
Taking into account the limited number of reports received by the Organization and the limited number of Member States that have submitted information on incidents related to these unsafe practices during the last four years, Contracting Governments may wish to recall that MSC 73 urged Governments and International Organizations to report promptly all unsafe practices associated with the trafficking or transport of illegal migrants by sea in accordance with, and in the format set out in MSC/Circ.836/Rev.1.

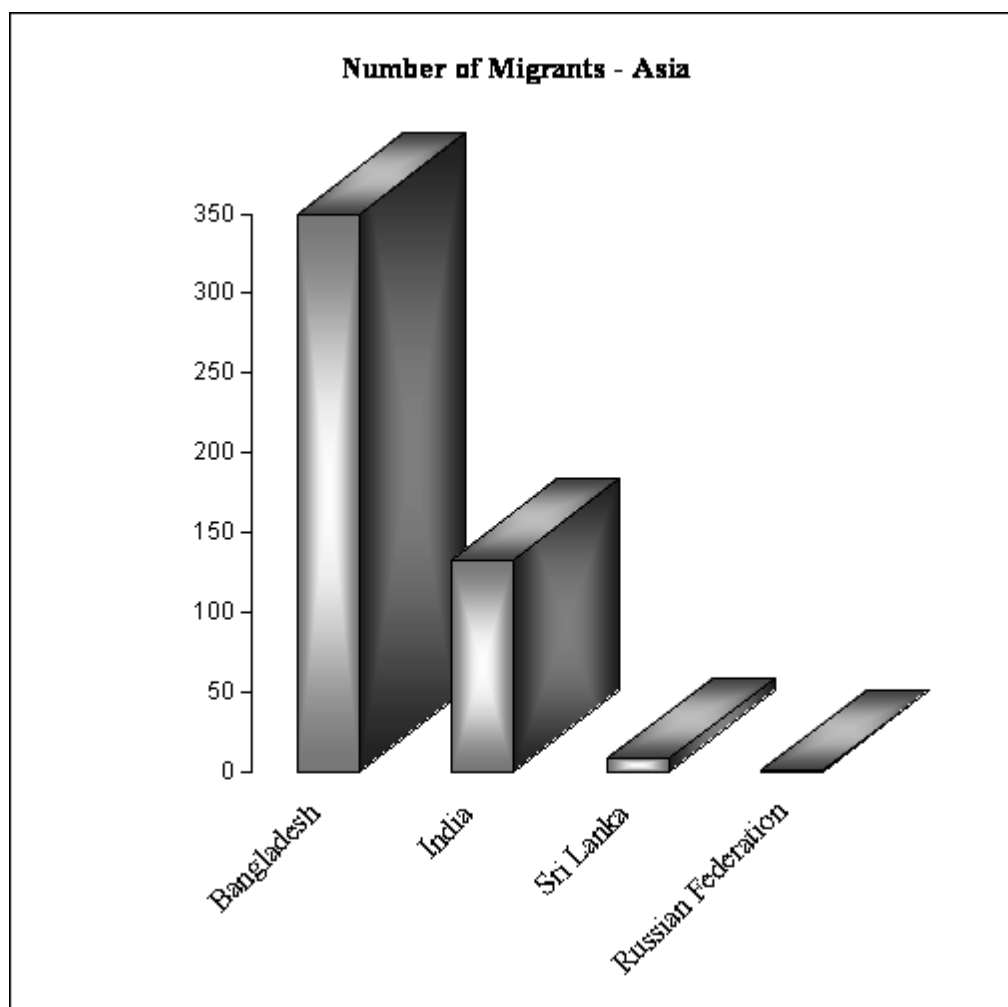

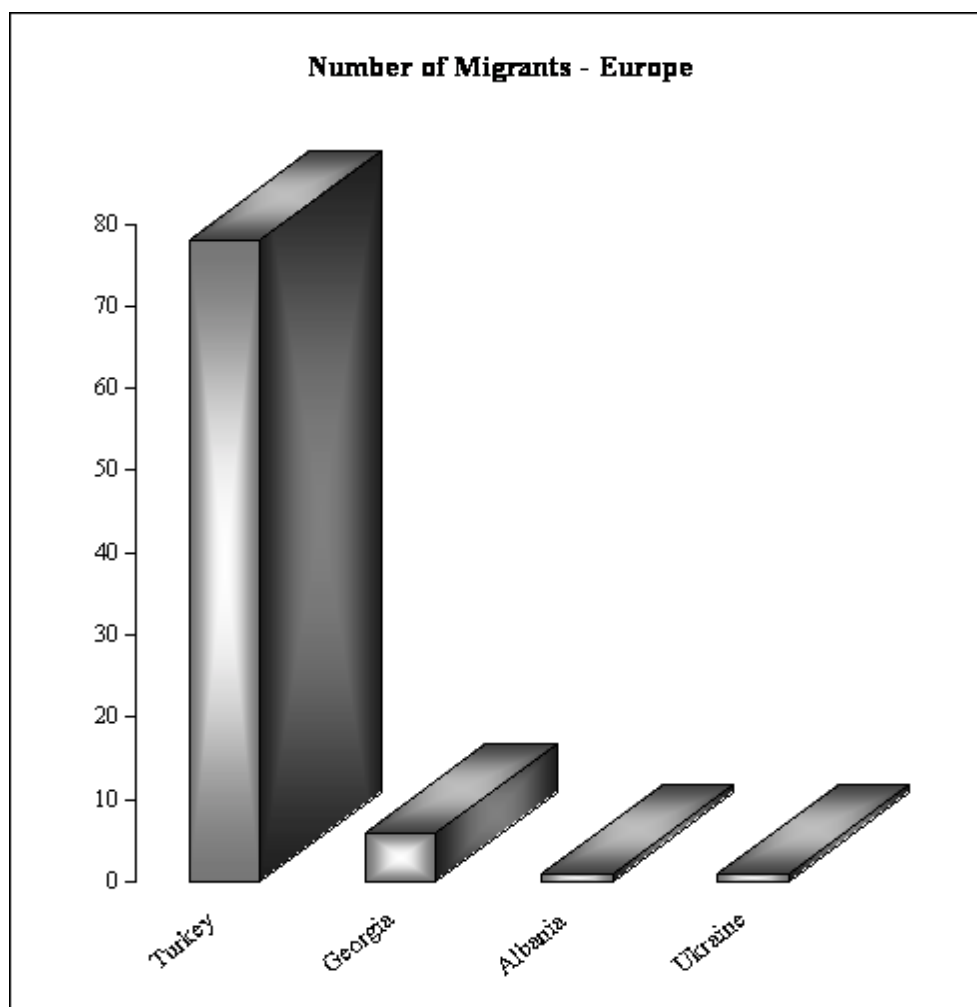

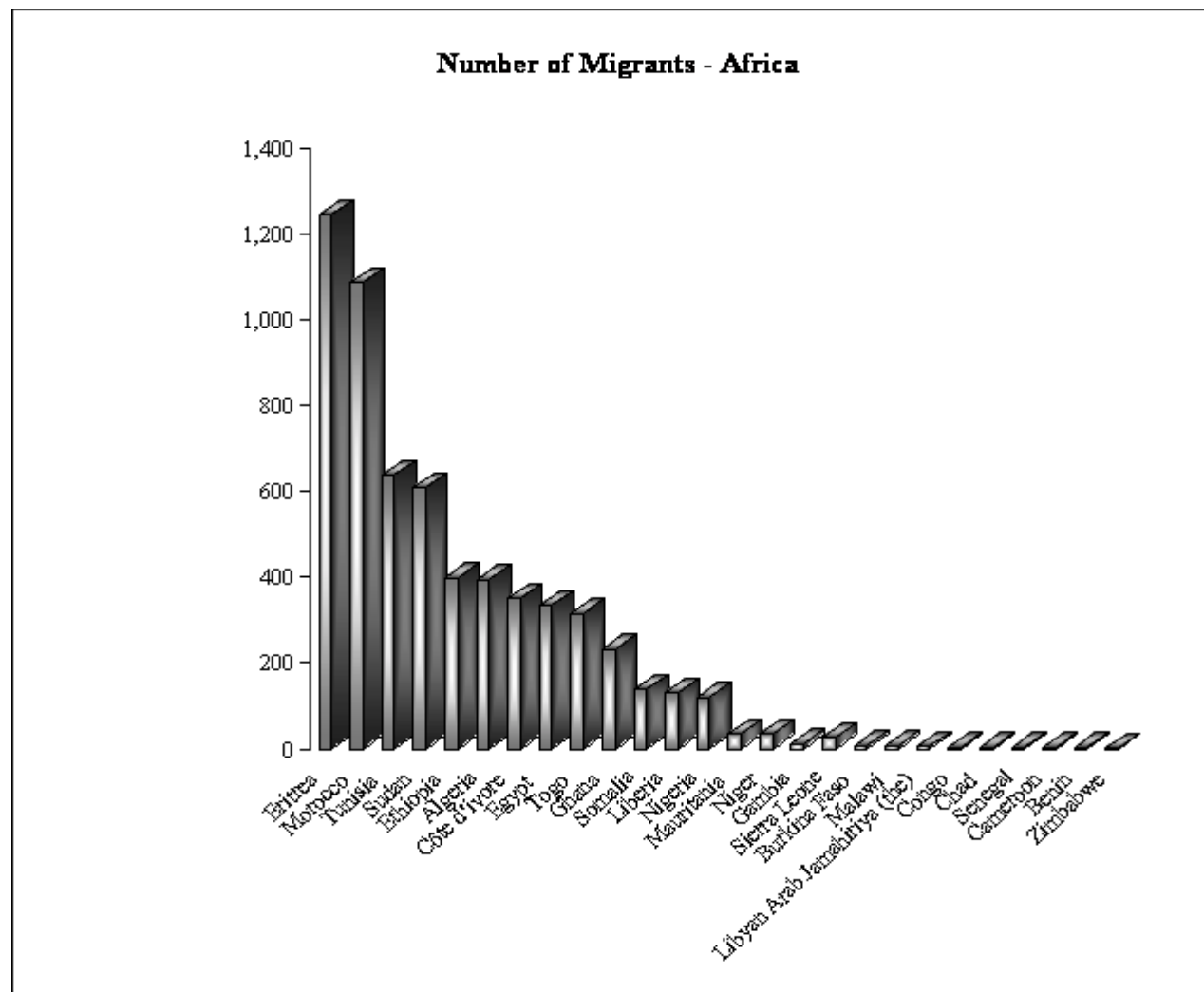

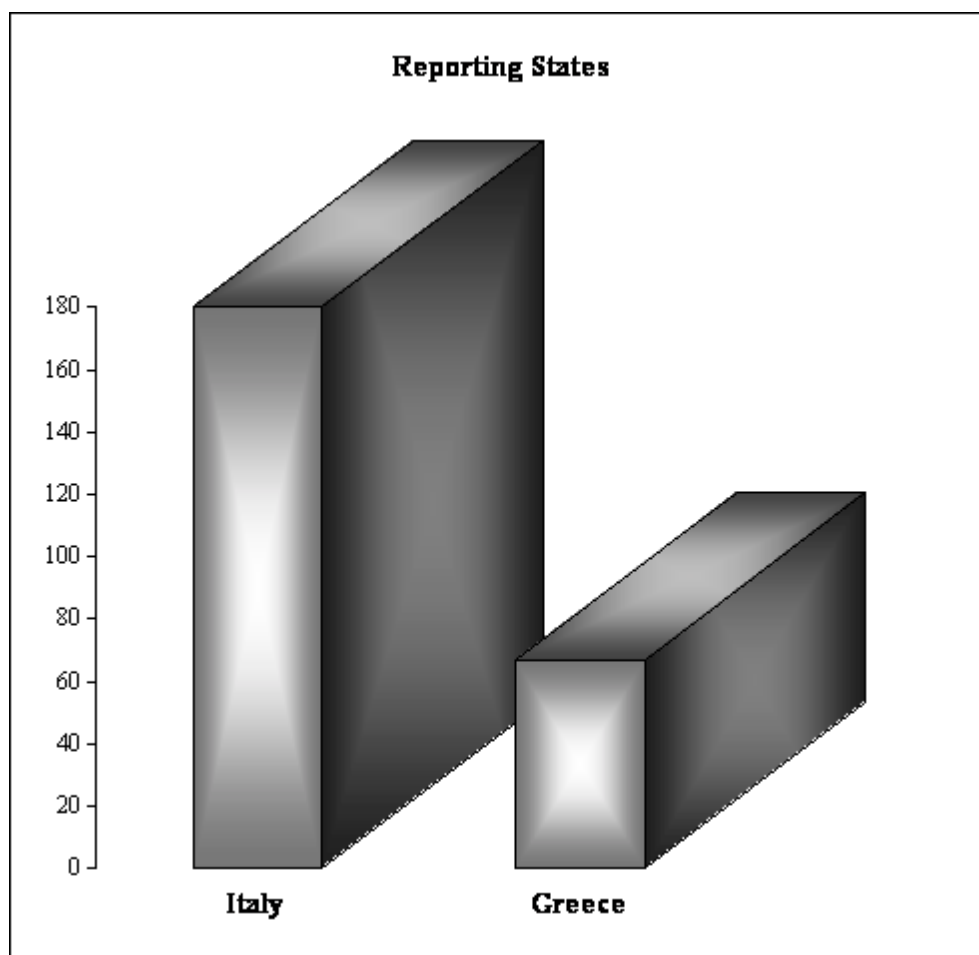

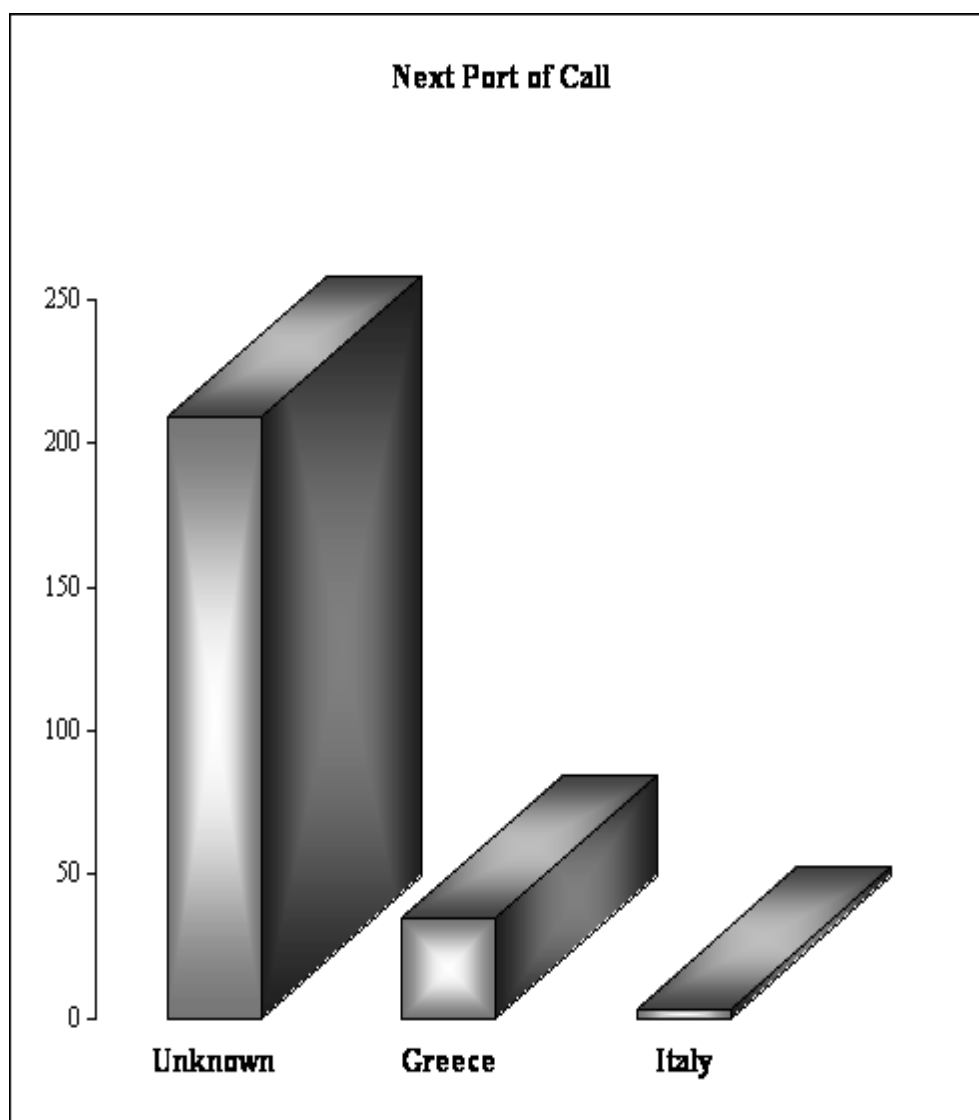
