RESOLUTION A.950(23) – MARITIME ASSISTANCE SERVICES (MAS)

Revised information on Maritime Assistance Services (MAS)

- 1 On 5 December 2003, the Assembly adopted resolution A.950(23) on *Maritime Assistance Services (MAS)*, whereby, inter alia, it invited Governments of coastal States that have established an MAS, for the purposes as described in the resolution, to forward to the Organization the details (i.e. call numbers, call signs, etc.) of their MAS, to enable the Organization to circulate such particulars, so that shipmasters and other persons or organizations concerned can make contact as necessary.
- 2 During the period January to June 2013, notification of a revised data on the Maritime Assistance Services has been received from the Government of Croatia, as set out in the annex.
- 3 Member Governments are invited to note the annexed information, which supersedes MSC.5/Circ.4 dated 19 July 2007, and bring it to the attention of all concerned, including shipowners and operators, shipping companies, shipmasters, etc. In addition, Member Governments are invited to provide information on MAS, as requested in resolution A.950(23).
