RESOLUTION A.950(23) – MARITIME ASSISTANCE SERVICES (MAS)

Information on Maritime Assistance Services (MAS)

1 On 5 December 2003, the Assembly adopted resolution A.950(23) on Maritime Assistance Services (MAS), whereby it, *inter alia*, invited Governments of coastal States that have established an MAS for the purposes as described in the resolution, to forward to the Organization the details (i.e. call numbers, call signs, etc.) of their MAS, to enable the Organization to circulate such particulars, so that shipmasters and other persons or organizations concerned can contact it as necessary.

2 During the period January to June 2008, notifications of the establishment of Maritime Assistance Services (MAS) have been received in February 2008 from the Government of the Republic of Ireland and in June 2008 from the Government of India, as set out in the annex.

3 Member Governments are invited to note the annexed information and bring it to the attention of all concerned, including shipowners and operators, shipping companies, shipmasters, etc. In addition, Member Governments are invited to provide information on MAS as requested in resolution A.950(23).
